DECLARATION LAW 20.393

Law 20.393 and its amendments on the criminal liability of legal entities in the crimes of money laundering, financing of terrorism, bribery, and fencing.

LiveSmart® Technologies SpA and its Shareholders and Legal Representatives acknowledge and are aware that their actions must at all times conform to the law, particularly regarding regulations on bribery, money laundering, financing of terrorism, and fencing, as outlined in Law 20.393 and its amendments (the "Sensitive Legislation"). In this regard, LiveSmart® Technologies SpA and its Shareholders and Legal Representatives acknowledge from now on that under no circumstances or events will any of their related individuals have any relationship or liability for any violation of the Sensitive Legislation.

In any case, **LiveSmart® Technologies SpA** and its Shareholders and Legal Representatives are obliged to prevent the assets that come directly or indirectly from, or to which they have access due to any contract, whatever its nature, from being used for illegal purposes and/or constituting a crime under the Sensitive Legislation. Similarly, they are obliged to avoid any improper behavior or conduct, such as bribery or "kickbacks," and, in general, any action or use of assets or funds with public or private entities or officials that constitutes the commission of illegal or inappropriate acts according to the policies and principles of the Sensitive Legislation and applicable legal regulations.

LiveSmart® Technologies SpA and its Shareholders and Legal Representatives state and accept that under no circumstances, and under no instructions from their employees or representatives, will they be authorized to engage in any of the conduct sanctioned by the Sensitive Legislation or any other, even under the pretext of fulfilling instructions from or that the result of the crime, supposedly, would benefit the Company.



Likewise, **LiveSmart® Technologies SpA** and its Shareholders and Legal Representatives are obliged to immediately inform about any situation of which they become aware, which could result in the illegal use of money or assets. In this regard, they are obliged to ensure permanently that the workers under their charge, subcontractors, contractors, and anyone associated with **LiveSmart® Technologies SpA** and its Shareholders and Legal Representatives refrain from carrying out, in their relationship or connection with LiveSmart® Technologies SpA, any illicit, improper, or contrary to established behavior.

The obligations and duties of **LiveSmart® Technologies SpA** and its Shareholders and Legal Representatives set forth in this declaration are essential, and any respective non-compliance will be considered a serious breach of the obligations imposed by the Law and Contracts and authorizes the immediate and *ipso facto* termination of their actions.
